



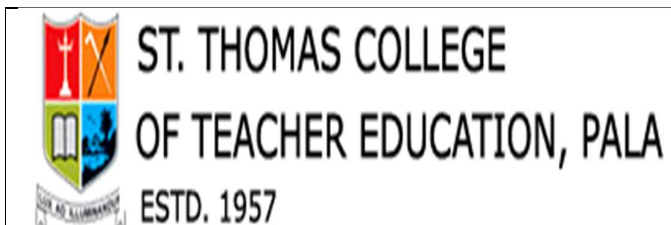

The N-LIST (National Library and Information Services Infrastructure for Scholarly Content) serves as our gateway to knowledge, offering access to e-resources for academic institutions. It offers access to over 6,000+ journals, 1,64,300+ e-books under N-LIST, and 6,00,000 e-books through NDL, benefiting colleges and universities across India. This report presents a comprehensive record of the N-List Annual Membership Fee payments made by St. Thomas College of Teacher Education spanning the years 2018 to 2024. It details each payment, specifying the year, invoice number, membership fee amount, date of payment, mode of payment, transaction ID, and remarks confirming that the payment was for the annual membership. The membership fee remained constant at INR 5900 for each year from 2018 to 2023.

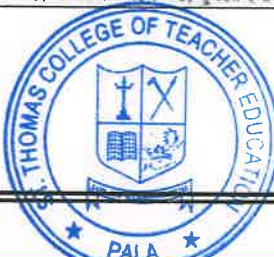
